### **Start of Major Works Announcement**

I'm sure you will have noticed by now that our activity in the local area has been steadily increasing since our enabling works began in February. Over the last few weeks, we have been busy carrying out vegetation clearance, surveys and preparing our site compound, all leading up to the start of major works in April.

Our scheme covers multiple junctions in the Runnymede area and the first phase of our scheme revolves around the St Peter's Way Roundabout. Our works around the roundabout will see:

- an extra lane constructed from the roundabout towards the M25 on the A320 eastbound,
- widening of the approach onto the roundabout from the M25 on the A320 westbound,
- widening of the northbound approach onto the roundabout from Guildford Road,
- widening of the footpath from the roundabout towards St Peter's Hospital
- resurfacing of the entire roundabout

### **A320 Westbound Lane Closure**

Overnight on the 7<sup>th</sup> of April we will be installing our first piece of full-time traffic management, this will be a lane closure on the A320 westbound, approaching the St Peter's Way Roundabout from the M25. This will see the start of construction to the new central reservation. This lane closure will remain in place until the middle of June.

We understand that our works will have an impact on the traffic around the area and there is likely to be increased congestion at peak times and for this we apologise in advance and thank you for your patience while we carry out these works.
