### **Blashford Tower**

I'm writing to provide you with an update on some activities that will be taking place in and around Blashford Tower shortly.

### **Meet and Greet**

Over the past few weeks we have carried out 'meet and greet' days for the residents at Blashford Tower. However, during these visits, we were unable to meet and/or speak to all our residents.

In order to ensure we have the opportunity to meet and/or speak to as many residents as possible, Ibbie Omideyi who is the Resident Liaison Manager from Graham Construction and Danielle Dallenger, Resident Engagement Lead (Camden Council's Project Team) will be attending **Blashford Tower** on **Friday 8<sup>th</sup> April between 4pm and 7pm**.

They will be knocking at doors for a brief introduction and we would be grateful if you could spare five to ten minutes of your time for a quick conversation on your doorstep with them. Please do raise any queries or concerns you may have.

### **Works on the MUGA area**

Further to my previous letter regarding the MUGA area, we apologise that the works have been delayed. This was due in part to Network Rail's approval process and the weather changes at that time.

I am now writing to inform you of the new dates that works will commence.

On **Monday 28<sup>th</sup> March** through to **Friday 15<sup>th</sup> April 2022**, we will be removing the undergrowth inside the MUGA area along with the vegetation and smaller trees. The MUGA area is the 'multi games' area behind the playground.

There are two mature trees to the left inside the MUGA area, which we will try and preserve, where possible.

The potential impacts to residents will include: -

- Noise disturbance to the immediate surrounding homes and general areas
- The presence of work persons outside the building as they have access to the Welfare facilities on the Lower Ground Floor in Blashford Tower
- The movement of materials and equipment
- The shredder parked on public foot path overlooking the playground area(s)
- Restricted access to the playground and public footpath will occur during this period

We apologise in advance that we will have to restrict the playground facilities while works are taking place, but as an alternative the closest playground to Blashford will be Dorney Tower.

Whilst these works are being carried out, we will endeavour to ensure that the process runs as smoothly as possible to minimise any inconvenience to the residents.

### **Show Flat - Works being carried out in Flat 17**

You may hear some noise coming from within flat 17 on the fifth floor as John Graham Construction are carrying out works to the show flat. These works are progressing over the next 2 weeks. You will see John Graham Construction operatives' going in and out of flat 17 as well as around the building. The impact on residents will be kept to a minimum.
