A523 Adlington Crossroads Improvement Scheme

As the Principal Contractor working with Cheshire East Council on the Poynton Relief Road project, we would like to inform you we will be commencing works to upgrade the A523 Adlington crossroads.

The works include the widening of the existing carriageway and upgrading the traffic light signals, with all works being completed by **late August 2022**. The aim of the crossroad improvement project is to improve traffic flow to accommodate the expected increase in traffic levels, when the Poynton Relief Road opens to traffic later this year.

Mill Lane Closure

To enable the widening of the carriageway we will be imposing a closure of Mill Lane at its junction with the A523 London Road. The 24-hour a day closure will take place from **6.00 am on Tuesday 5th April** until **late August**. During the period of the works, we will manage the crossroads with 3-way temporary traffic lights 24 hours a day.

A signed diversion route will be in place for the duration of the road closure.
