A523 Bonis Hall Lane –Junction Improvement Works

As the Principal Contractor working with Cheshire East Council and Stockport Borough Council on the Poynton Relief Road project, we would like to inform you we will be undertaking the next phase of the A523 Bonis Hall Lane junction improvement scheme.

The works include the creation of new filter lanes and the widening of the existing carriageway. The works will take place from **Monday 13th September** until **late February 2022**. The aim of the junction improvement project is to improve safety and traffic flow, which will greatly reduce congestion at this busy junction.

Traffic Management

To facilitate our construction activities including the widening of the existing carriageway, we will be imposing 3-way temporary traffic lights 24 hours a day for the duration of the works.
